EVALUATION STUDY MENPORA CUP WOMEN'S U-17 TIERED LEAGUE COMPETITION

Abstract The purpose of this study was to evaluate the 2019 Menpora Cup Women's U-17 Tiered League Competition Program. This study used a qualitative technique with an evaluation approach using the Context, Input, Process and Product (CIPP) model. The method of collecting data is triangulation using questionnaires, interviews, document studies and observation. The result of the research show that in: (1) Context Evaluation: has a very strong legal basis and government policy, with good intentions and goals, but not yet targeted. (2) Input evaluation: participants, organization, financing and committee have not been carried out properly and need to be improved in accordance with the development of the Menpora Cup Women's U-17 tiered league competition every year. (3) Process Evaluation: sporting competition rules that must always be updated in accordance with football developments, competition implementation still needs to be maximized properly. (4) Product Evaluation: increasing public participation and interest in organizing the Menpora Cup Women's U-17 tiered league competition every year, the role of the media in publication and promotion of sports to the community is increasingly being expanded, and efforts to find potential sports athletes from the community that need to be developed optimized. However, athletes' achievements have not contributed much to world-class achievements.

INTRODUCTION

Good development in the scope of sports according to Law number 3 of 2005 concerning the National Sports System includes activities of (1) educational sports; (2) recreational sports; and (3) achievement sports. For sports, achievement is carried out through a planned, tiered, and sustainable coaching and development process with the support of sports science and technology. Apart from good coaching in sports, training program planning must also be adjusted to the athlete's characteristics and what targets to achieve.

Long-term training program must be made in order to determine achievement targets and to achieve them must pay attention to. Programmed training programs, competitions as well as recovery are based on the athlete's biological age (individual maturity level) and not based on chronological age. Focusing primarily on athletes, supported by professional coaches, management, sports science and sponsors, an athlete undergoing a training and competition program will receive a periodization plan that is appropriate to his biological age and developmental needs.

The government as the highest institution that regulates the prosperity of the Indonesian nation has a very important role in shaping the nation's character through sports. The Ministry of Youth and Sports as part of the Indonesian government that deals with youth and sports is trying to develop and improve sports achievements, especially soccer in Indonesia, where the current state of achievement is quite worrying. The current condition of Indonesian football is still unable to achieve achievements at the level of other Asian countries. At the level of Southeast Asia alone, our achievements are still below Thailand. This can happen because of several factors that become problems in developing achievement in Indonesia. The lagging achievements of Indonesian football need fundamental improvements. Starting with a focus on fixing youth development as the foundation. In order for youth development to run well, the Government needs to facilitate various tiered competitions in groups of U-12, U-14, U-16, U-17, U19 and U-21.

The 2019 Menpora Cup Women's U-17 Tiered League Competition is one of the flagship annual programs in the work program of the Minister of Youth

and Sports as well as being one of the solutions to problems that occur in developing soccer sports achievements as early as possible in Indonesia. The main goal is to attract talented soccer athletes throughout Indonesia from the basic level to the professional level for gradual and sustainable coaching. Aims to attract the best young footballers to strengthen the national team in international competitions according to their age level and to be part of the ladder of coaching young players in stages as well as to provide a forum for positive activities among students to prevent the dangers of drug use and other negative behaviors.

METHOD

The implementation of this research was carried out through a program evaluation approach with a descriptive method. Descriptive method is a method that is carried out by describing the findings carried out through problem solving procedures, investigated by describing / describing the state of the subject / object of research. For this reason, this method was formed in order to be able to provide findings on the evaluation of the 2019 Menpora Cup Women's U-17 Tiered

League Competition program and describe it in detail.

To find out more information about the Menpora Cup 2019 Women's U-17 Tiered League Competition program, researchers used design as a concept in starting the evaluation of the Menpora Menpora Cup 2019 Women's U-17 Tiered League Competition. The findings in the context evaluation will discuss the findings on planning indicator with subfocuses, including: (1) legal basis and government policies, (2) aims and objectives, (3) targets.

Menpora Cup 2019 Women's U-17 is expected to produce national football athletes. The findings on the context dimension are:

a. The 2019 Menpora Cup Women's U-17 Tiered League Competition has a strong legal basis and government policy. The legal basis and government policies have 8 points, namely (1) Law No. 3 of 2005

concerning the National Sports System, (2) Law of the Republic of Indonesia Number: 20 of 2003 concerning the National Education System (3) Government Regulation of the Republic of Indonesia Number :16 of 2007 concerning the Implementation of Sports, (4) Government Regulation of the Republic of Indonesia Number: 17 of 2007 concerning the Organizing of Sports Weeks and Championships, (5) Government Regulation of the Republic of Indonesia Number: 18 of 2007 concerning Sports Funding.

b. Menpora Cup 2019 Women's U-17 Tiered League Competition has a very clear purpose, has a pretty good goal. Goals are a description of the mission statement and are something that will be achieved or produced within a predetermined period of time. Goals will direct the formulation of goals, and activities in order to realize the mission, so that the goals are harmonious and clarify the vision and mission, describe the results of the program and describe a clear direction of an organization

c. Menpora Cup 2019 Women's U-17 Tiered League Competition has clear and precise targets. Goals are a

description of the goals of an organization in the final form and will be achieved or produced within an annual, semi-annual or monthly period. Goals also describe what is to be achieved through the actions taken to achieve the goal. Therefore, the targets set are expected to provide a focus on the preparation of programs and activities that are specific, detailed, measurable and achievable. From the findings that the target of the 2019 Menpora Women's U-17 Tiered League Competition has not been achieved optimally because it has not been fully supported by all related parties. So that all programs that have been running are not optimal. In the implementation of this evaluation, it is carried out in a clear and well-documented manner, and is able to be socialized to coaches, athletes, and all components involved

2. Input Evaluation

The findings in the input evaluation will discuss the findings in the sub-focuses, including: (1) participants, (2) organizers, (3) financing, (4) committee. The input evaluation is intended to record or identify the objective conditions of resource support owned by

the 2019 Menpora Cup Women's U-17 Tiered League Competition. The input findings are:

- a. The spearhead of female student football development are the participants of the 2019 Menpora Cup Women's U-17 Tiered League Competition which is expected to be the forerunner of quality football athletes who are able to raise the image of regional sports in various national events as well as the name of the nation and state in international events. - a. 4. Product Evaluation

The sub-focuses are (1) the level of participation and public interest, (2) the role of the media in publication and promotion of sports. to the community, and (3) The emergence of potential sportsmen from the community. The findings that the researchers got were:

a. The implementation of the Menpora Cup 2019 Women's U-17 Tiered League Competition will have an impact on several factors including inviting public

interest and participation around the 2019 Menpora Cup Women's U-17 Tiered League Competition. Evaluation at this stage is carried out with the aim of knowing how big the level of participation and public interest in the implementation of the 2019 Menpora Cup Women's U-17 Tiered League Competition program and the implementation is categorized as well implemented.

b. The role of media publications and promotion of sports in the community is one of the most important factors for the success of organizing the 2019 Menpora Menpora Cup Women's U-17 Tiered League Competition. Therefore, the committee really needs the role of the media, publication and promotion of sports to the public so that the messages contained in the activities can be conveyed effectively. to the wider community. When the intent of the 2019 Menpora Cup Women's U-17 Tiered League Competition was able to be conveyed properly to the public, it became one of the

benchmarks for the success of the event being held. Thus the role of media and sports promotion can be carried out properly and accordingly.

- c. One of the successes of organizing the 2019 Menpora Menpora Cup Women's U-17 Tiered League Competition as an effort to foster the achievements of student football athletes is the emergence of many potential sports seeds from the community, especially superior soccer athletes whose future prospects are expected to be able to become Indonesian national team squads that are ready compete on the international stage. Thus it can be categorized as successful and appropriate.

CONCLUSION

Based on the discussion regarding the 2019 Menpora Cup Women's U-17 Tiered League Competition program, it can be concluded, namely:

- 1) The process of the selection mechanism for the 2018 Menpora Cup U-16 Tiered League participants refers to the achievements of athletes both at the regional and national levels, from the

results of the 2019 Menpora Cup Women's U-17 Tiered League Competition regarding the expectations of efforts to develop young soccer athletes for their achievements. already good, namely through professional selection (there are terms and conditions).

- 2) The implementation of the Menpora Cup 2019 Women's U-17 Tiered League Competition program runs regularly and sustainably, from the evaluation results of the 2019 Menpora Menpora Cup Women's U-17 Tiered League Competition regarding aspects of the implementation of the program the achievement is good, namely the existence of continuous competition.

- 3) The supporting facilities and infrastructure as a whole are in a good level and suitable for use. from the results of the evaluation of the 2019 Menpora Cup Women's U-17 Tiered League Competition coaching program regarding the facilities and infrastructure aspects, the achievement is good, namely the completeness and feasibility of facilities and infrastructure.

- 4) The 2019 Menpora Cup Women's U-17 Tiered League Competition applies a positive and competitive system that leads to

maximum achievement. From the results of the evaluation of the football coaching program through the 2019 Menpora Cup Women's U-17 Tiered League Competition program regarding the aspect of competition regulations, the achievements are good, namely the implementation of a good and accountable competition system.
